## **2018 Spring Applicant Program**

To All Applicants:

After you have completed the **online** application, please make a copy of the following information and keep it for your records.

### **NEW APPLICANT REQUIREMENTS FOR MEMBERSHIP INTO IAABO BOARD #33:**

- Applicant must reside in one of the following counties: BERGEN, ESSEX, HUDSON, MIDDLESEX, PASSAIC, SOMERSET, or UNION.
- Application Form to be completed and submitted **online** no later than **March 9, 2018**.
- **Application fee of \$250.00** to be paid on-line at time of application, or by check no later than 7 days after the application is submitted.
- A completed medical clearance form signed by the applicant's personal physician and submitted prior to the first class.
- **Refund Policy** - The application fee will be returned in full, minus a \$50.00 processing fee if the applicant withdraws from the program before the start of classes. A 50% refund will be returned if the applicant withdraws from the program during the first week of classes. No refunds will be issued thereafter.

### **PROGRAM REQUIREMENTS:**

- Rules classes and examination (dates, times and locations listed below)
- All applicants must attend a **minimum of nine (9) rules interpretation meetings** (not including the exam date of **May 14, 2018**) and successfully pass the IAABO Exam with a minimum score of **86%**. Applicants who do not pass the exam, may reapply the following year.
- Successful applicants will move into Phase 2 (Mechanics).
- In Phase 2, applicants will attend meetings dedicated to on court mechanics.
- All applicants **are required** to attend all mechanics sessions **and are subject to pass a written mechanics examination and a practical floor test**.
- **Practical floor test includes attendance at a supervised clinic / scrimmage (dates & times TBD)**

### **SECOND YEAR REQUIREMENTS:**

- Submitting (and passing) a refresher written exam for the 2018-19 season.
- In addition to attending 3 regular membership meetings (Board 33), applicants may be required to attend additional meetings with a concentration on rules interpretation, mechanics and philosophy of officiating.

## **2018 IAABO BOARD #33 RULES AND MECHANICS CLASSES**

The following dates are scheduled for rules interpretation and mechanics classes. Classes will begin at 7:00 pm and end at 9:00 pm., and will be held at Bloomfield High School in Bloomfield, New Jersey. **Applicants must attend a minimum of nine (9) rules classes (Exam date not included) and (4) four mechanics classes.**
